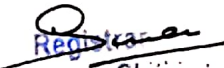

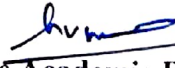

Opening Remarks:

At the outset of the meeting, the Registrar welcomed the Hon'ble Vice-Chancellor and Chairperson of the Executive Council. Thereafter, the Vice Chancellor welcomed

Dr. Avijit Mukherjee, a newly member nominated by the Hon'ble Governor –Chancellor in the EC of this University and other Hon'ble members of the Executive Council.

The Vice- Chancellor as Chairperson, Executive Council of Shri Vishwakarma Skill University, Palwal apprise the members of the EC about the brief progress report of the University regarding starting of new programmes started from this academic session and increase in the strength of students'.

Thereafter, Prof (Dr.). S.P.Bansal, Prof.(Dr.) R.P. Saini, Vice-Chancellor, Hon'ble members of the EC gave valuable suggestions regarding skill programmes, which were noted Being Engineering Day Prof. S.P.Bansal suggested to upgrade the existing course curriculum according to NEP-2020 and planning may be done for next Five years as Shri Vishwakarma Skill University is the first Skill University and may be role model for Haryana State.

After that, with the permission of the chair, the agenda items were taken up as follows.
