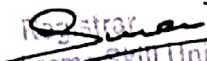

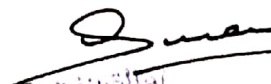

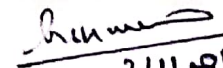

Opening Remarks:

At the outset of the meeting, the Registrar welcomed the Hon'ble Vice-Chancellor and Chairperson of the Executive Council. Thereafter, the Vice Chancellor welcomed the Hon'ble the members of the Executive Council and after that with the permission of the chair, the agenda items were taken up as follows.

EC/47/01: TO REVIEW AND DECIDE THE FURTHER COURSE OF ACTION ON THE LEGAL OPINION RENDERED BY THE LD. COUNSEL FOR THE UNIVERSITY IN CWP NO. 28535 OF 2022 PENDING BEFORE THE HON'BLW PUNJAB AND HARYANA HIGH COURT.

The Executive Council considered the agenda, Legal Opinion rendered by University Counsel Sh. Puneet Gupta, Advocate and requirement of the University. After detailed deliberation and keeping in view the increase in volume of work due to start of new programmes, students and faculty, the Council unanimously resolved that a request may be made to the Finance Department, Government of Haryana through Skill Development Industrial Training for creation of one post of Deputy Registrar in SVSU, Palwal in FPL-12, as all three existing sanctioned posts are already occupied, and creating the new post is the only path available to satisfy judicial scrutiny and secure the recruitment matrix and to cater the administrative exigencies.

EC/47/02: ANY OTHER ITEM WITH THE PERMISSION OF THE CHAIR.

The Vice-Chancellor-cum-Chairperson, Executive Council, SVSU, Palwal brought to the notice of the Executive Council that no age limit has been prescribed by this University for the post of Skill Professors, Skill Associate Professors and Skill Assistant Professors in this University. After detailed deliberations, the Council resolved that the age limit for the posts of Skill Professors, Skill Associate Professors and Skill Assistant Professors of UGC may be adopted. However, the retirement age of all above posts shall be subject to rules, regulations and notifications issued by Govt. of Haryana from time to time with respect to the State Govt. Universities.

The meeting ended with a vote of thanks to the chair.
